The Library Director requests to use \$400 of the donation to refresh the children's chapter books and \$600 towards the purchase of an electronic game table. The Library has some additional unused donation money and the Director would like to use it for laser tag equipment. She has done some research & discovered most of the better rated sets are approximately \$100 each. Riggs made a motion to approved spending a max of \$250 for 2 laser tag sets. Risney 2nd.
